


The National Assessment of Educational Progress (NAEP) assesses reading on a 0-500 point scale. In 2003, Charlotte-Mecklenburg Schools was one of nine urban districts that voluntarily participated in the NAEP reading assessment on a trial basis.

Overall Reading Results for Charlotte

- In 2003, the average scale score for fourth-grade students in Charlotte was 219. This was not found to be significantly different¹ from that of the nation's public schools (216).
- Charlotte's average score (219) in 2003 was higher than that of public schools in large central cities² (205), and not significantly different from that of North Carolina (221).
- The percentage of students in Charlotte who performed at or above the NAEP *Proficient* level was 31 percent in 2003. The percentage of students in Charlotte who performed at or above the *Basic* level was 64 percent.

NOTE: The NAEP reading scale ranges from 0 to 500, with the achievement levels corresponding to the following points: *Below Basic*, 207 or lower; *Basic*, 208-237; *Proficient*, 238-267; *Advanced*, 268 or above.

Average Score Gaps Between Selected Groups

- In 2003, male students in Charlotte had an average score that was lower than that of female students (15 points). This performance gap was wider than that of the Nation (8 points).
- In 2003, White students had an average score that was higher than that of Black students (33 points). This performance gap was not significantly different from that of the Nation (30 points).
- In 2003, White students had an average score that was higher than that of Hispanic students (35 points). This performance gap was not significantly different from that of the Nation (28 points).
- In 2003, students who were not eligible for free/reduced-price school lunch had an average score that was higher than that of students who were eligible (34 points). This performance gap was wider than that of the Nation (28 points).

An examination of scores at different percentiles on the 0-500 NAEP reading scale at each grade indicates how well students at lower, middle, and higher levels of the distribution performed. For example, the data above show that 75 percent of students in public schools nationally scored below 243, and 75 percent of students in Charlotte scored below 244.

¹ Comparisons (higher/lower/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Performance comparisons may be affected by differences in exclusion rates for students with disabilities and limited-English-proficient students in the NAEP samples and changes in sample sizes. NAEP sample sizes have increased since 2002 compared to previous years, resulting in smaller detectable differences than in previous assessments.

² "Large central city" includes nationally representative public schools located in large central cities within metropolitan statistical areas as defined by the federal Office of Management and Budget. It is not synonymous with "inner city." In Charlotte, 14 percent of students were in "Fringe/large city" areas and 11 percent of students were in "Rural" areas.

³ For comparison, minority students comprised 77 percent of students in large central city public schools and 41 percent in public schools nationally. Also, students eligible for free/reduced-price school lunch comprised 69 percent of students in large central city public schools and 44 percent in public schools nationally.

NOTE: Detail may not sum to totals because of rounding, and because the "Information not available" category for Free/reduced-price lunch is not displayed. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages.
