


The National Assessment of Educational Progress (NAEP) assesses reading in two content areas in grade 4: reading for literary experience and to gain information. The NAEP reading scale ranges from 0 to 500.

**Overall Reading Results for Florida**

- In 2007, the average scale score for fourth-grade students in Florida was 224. This was higher than their average score in 2005 (219) and was higher than their average score in 1992 (208).<sup>1</sup>
- Florida's average score (224) in 2007 was higher than that of the nation's public schools (220).
- Of the 52 states and other jurisdictions that participated in the 2007 fourth-grade assessment, students' average scale score in Florida was higher than those in 22 jurisdictions, not significantly different from those in 19 jurisdictions, and lower than those in 10 jurisdictions.<sup>2</sup>
- The percentage of students in Florida who performed at or above the NAEP *Proficient* level was 34 percent in 2007. This percentage was greater than that in 2005 (30 percent) and was greater than that in 1992 (21 percent).
- The percentage of students in Florida who performed at or above the NAEP *Basic* level was 70 percent in 2007. This percentage was greater than that in 2005 (65 percent) and was greater than that in 1992 (53 percent).



**Average Score Gaps Between Selected Groups**

- In 2007, male students in Florida had an average score that was lower than that of female students by 8 points. In 1992, the average score for male students was lower than that of female students by 6 points.
- In 2007, Black students had an average score that was lower than that of White students by 24 points. This performance gap was narrower than that of 1992 (33 points).
- In 2007, Hispanic students had an average score that was lower than that of White students by 14 points. In 1992, the average score for Hispanic students was lower than that of White students by 15 points.
- In 2007, students who were eligible for free/reduced-price school lunch, a proxy for poverty, had an average score that was lower than that of students who were not eligible for free/reduced-price school lunch by 21 points. This performance gap was narrower than that of 1998 (29 points).
- In 2007, the score gap between students at the 75th percentile and students at the 25th percentile was 43 points. This performance gap was narrower than that of 1992 (49 points).

<sup>1</sup> Comparisons (higher/lower/narrower/wider/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages. Comparisons across jurisdictions and comparisons with the nation or within a jurisdiction across years may be affected by differences in exclusion rates for students with disabilities (SD) and English language learners (ELL). The exclusion rates for SD and ELL in Florida were 4 percent and 4 percent in 2007, respectively.
